The design, evolution and findings of the seminar will be reviewed. Presenter: Joy Helmer, M.S., is a VOM mediator and trainer in Seattle. She is deeply involved in RJ issues in Washington State. Joy has been a psychiatric nurse and practiced for over 30 years in mental health arena.

Training A Introductory VOM Training (3 day -Basic) This experiential, interactive training is designed to provide participants with a basic understanding of the victim-offender mediation process and the skills necessary to mediate effectively. Gain understanding of victims and offenders, explore benefits and risks of the process, and learn restorative justice concepts. Through presentations, exercises, role-plays, and demonstrations, develop skills in communication, facilitation, and mediation. Following training, participants will need to apprentice with experienced mediators. (limited to 30 participants)

Training B The Circle Process - A Restorative Justice Concept (2 day -Basic) This training will consist of experiential learning in the circle areas of Application/referral, Social Compact, Healing Circle(s), Sentencing Circle, and Sentence Covenant. Also covered will be the role of circle keeper, now called circle supporter. This will be a nuts and bolts type of training where you will experience all of the above. Trainers: Terry Anfinson is the Executive Director of the Anishinabe OIC on the Mills Lacs Reservation, host to the Mills Lacs Community Circle Process; Gerri Gabbow is the Coordinator for the Mills Lacs Community Process Circle. Mediated Dialogue in Crimes of Severe Violence: An interactive overview (1 day -Basic) Training C Presenters and training participants interact regarding information and materials shared about the development of five unique programs which primarily or exclusively facilitate mediated dialogue in crimes of severe violence. Presentations will cover basic core beliefs and value-based practices; philosophy and approach in screening, training and support related to use of volunteers; in-system development/ administration issues; role of the mediator; content and extent of preparation of both victim and offender throughout the process; and specific training opportunities available in order to initiate this process. A pilot project, the Community Justice Zone, was created by grassroots community action, along with a vision to build communities that embrace principles, philosophy and practices of Restorative Justice. The Minnesota State Legislature and Dakota County Corrections are supporting plans in three cities to involve citizens more fully in crime prevention and intervention. This training will focus on how to start and expand a program. Participants should have a basic understanding of VOM/C. This training will focus on administrative issues including referral sources, utilizing volunteers, collaborating with community agencies and funding. In addition, issues of building support and relationships in the community will be addressed.

This workshop takes a look at some of the lessons learned by one community. It is designed for those who are trying to develop or expand their programs.

This interactive training will draw on areas of expertise of the presenters and will enable participants to hone existing skills, share experiences and struggles and deepen understanding of victim offender issues. Theory sessions will be interspersed with practical skills and coached role-plays in order to give participants a chance to put skills into practice. The training will include the examination of advanced communication skills, positions and interests, case-development issues, and the importance of mediation model flexibility. Trainer: Dorothy Barg Neufeld has been involved in VOM as a caseworker and trainer at Mediation Services in Winnipeg for thirteen years and is active in the development of restorative justice practices; Sandra Koop Harder has been involved in victim offender mediation since 1996 doing volunteer coordination, casework and trainings for Mediation Services.

Workshop 33 - The Role and Power of 'Ritual' in the Conference Process The purpose of this workshop is to expand our thinking and creativity for the benefit of victims, offenders and community conference participants. We will discuss methods of opening and closing a conference session in ways that: engage participants and enhance the meaning of the conference for them, help set the tone of the conference 'up front' and close the session by affirming the work they've accomplished together. The workshop will present ideas and participants will interact and learn from each other. Presenter: Terri Grob has been involved in the RJ field since 1991 as volunteer mediator, program manager, trainer, presenter, statewide community organizer and now as contractor/consultant in her own business: "Restorative Justice Project."

Workshop 34 - Keeping the Pieces: A Unified Family Court Model for Child Protection Using Mediation

This workshop will describe the first two years' experience with this model project which, beginning with a child protection case, unifies all court cases involving a family before one judge and employs the same team of child protection workers, attorneys, and family support resources to address all the cases. Using mediation, the parties attempt to resolve all the cases involving the family, including felony child abuse or neglect charges, rapidly and with the best interests of the children guiding the process. Presenter: Thomas L. Rhorer, M.Div., J.D., is an attorney/mediator whose law practice focuses on the representation of children and whose mediation practice centers on child protection, high conflict divorce and special education; Susan K. Wiese, M.S.W. is coordinator of Mediation Services in LaCrosse, WI. Mediation experience includes VOM, workplace and child protection mediation. Sue is treasurer of the VOMA board.

Workshop 35 - Community Impact Panels - A Presentation

The community impact panel program brings together those who offend and community representatives in a facilitated meeting. The goals of the panels include giving the community a more meaningful role in the justice system, reducing recidivism rates, and devising strategies to prevent future offenses. The session will review the panel's facilitative model, strategies for identifying potential community issues and members, and a brief role play.

Presenter: Stuart Sears, the Coordinator of the Victim Services' Dispute Resolution Program at the Midtown Community Court (NYC), holds a Masters Degree in Contemplative Psychotherapy from the Naropa Institute.

Workshop 27 - Public Relations Potential in Victim Offender Mediation/Conferencing Programs

Effective Publicity is a must for developing a restorative justice/victim offender mediation/conferencing program. Public Relations is a 24/ 7 activity. Some public relations activities are obvious but some are not. This workshop will help you identify public relations opportunities that are often overlooked. Participants will discover some practical tools for maximizing public relations effectiveness by seizing every public relations opportunity.

Presenter: Rick Rodrick teaches courses in Public Relations and Organizational Communication in the Communication Studies Department at the University of Wisconsin - LaCrosse where he is an Assistant Professor.

Workshop 28 - Important Moments Inside the Process of Mediation

This workshop will explore sure issues as getting information without asking questions once we realize our questions have a certain intention and effect; the difference between observing on one side and evaluating, analyzing, judging on the other side. Questions such as "What is fairness when compared to diversity in culture and origin?" and "What is truth compared to the eye of the observer?" will be discussed. Differences in communication methods between the transformative approach compared to the settlement driver approach will also be addressed.

Presenter: Hans Boserup is an attorney in Denmark. He is also a trainer of mediation in the US, Ireland and Germany and the author of several books and articles.

Workshop 29 - Restorative Justice in Federal Death Penalty Cases

Bringing restorative justice concepts to federal death penalty cases is being done through a Soros Justice Fellowship in partnership with the Federal Death Penalty Resource Counsel Project. Originally developed during the Oklahoma City bombing this work seeks to help judges, prosecutors and defense attorneys think restoratively about responding to homicide cases.

Presenters: Tammy Krause, MA in Conflict Transformation, Soros Justice Fellow, victim liaison, has worked with defense teams on ten federal capital cases in outreach to victims' families; Bruce Kittle, J.D. and M. Div., Director of Restorative Justice Project, University of Wisconsin Law School, Madison, WI.

Workshop 30 - Restorative Justice Planning and Circles: A Successful School and Community Collaboration

Restorative justice planning in school creates an understanding of what happened, what was the underlying issue of conflict, who was affected and what can be done to repair the harm experienced. The Circle helps repair the harm together rather than send out the individual from the educational setting where learning takes place. This workshop will listen to real situations which might have resulted in court action yet were resolved through collaboration. Data gathered from actual school community participants following the process will be reviewed and opportunity to witness/role play scenarios following an overview of the circle process will be provided. Presenter: Mary Leadem Ticiu is the Restorative Justice Planner at Lincoln and District Restorative Justice Coordinator for South Saint Paul Public Schools; Stacy Elliott Sarff is a Restorative Justice Planner and teacher on special assignment to serve K-6 building of nearly 900 students in the South Saint Paul Schools; Michael Stanefski is a Restorative Justice Planner in 7-12 Junior/Senior High School setting and a licensed school social worker; Jam Lanus is the High School Dean for South Saint Paul Public Schools.

Workshop 31A - Expanding VOM Practice into the 21st Century (PART 1)

This workshop will provide an opportunity to move beyond the basic two-party, face-to-face mediation practice to conferences and circles involving more participants: victims and offenders (or parties in conflict), immediate and extended family members, other members of their community, mentors, other systems representatives, etc. Workshop attendees will be introduced to a variety of processes that creatively combine options to meet the specific needs of the participants.

Training I Restorative Justice Conferencing Program Models and Curriculums (1 day -Basic)

This training will feature a smorgasbord of program models and curriculums being used throughout the country. Some of those featured will include the Restorative Group Conferencing curriculum that will be available for national distribution through the National Institute of Corrections as well as curriculums from Colorado, Pennsylvania and Minnesota. Trainer: Carolyn McLeod, program coordinator for Washington County Court Services Community Justice in Stillwater, MN and a nationally recognized trainer/leader in innovative restorative justice practices; Susan L. Stacey, is a Restorative Justice Planner for the Minnesota Department of Corrections with a background in community organizing, law, training and work with victims and offenders for twenty years; Lorraine Stutzman Amstutz, Director, Mennonite Central Committee Office on Crime and Justice, Quakertown, PA and co-author of the VOC curriculum used in Pennsylvania's Juvenile Justice System.

Exploring VOM as Early Intervention in Domestic Violence Cases (1 day -Advanced) Training J

The Edmonton Victim Offender Mediation Society (Alberta, Canada) has mediated slective spousal assault cases over the past two years. Through sharing information, group discussion and role-play demonstration, the presenters will help provide insight into the role that VOM can play in certain cases of spousal domestic violence. Trainers: Alan Edwards mediates with EVOMS and instructs ADR courses for the University of Alberta and the Alberta Arbitration and Mediation Society (AAMS); Judith Lake mediates for EVOMS and the Alberta Justice Civil Claims Mediation Program and coaches ADR courses for the University of Alberta and the AAMS.

Training K Basic Offender Sensitivity (1/2 day morning -Basic)

The basic tenets for working "sensitively" with offenders begins with the practitioner's self-awareness. From that "base-line of heartknowledge" flows a relationship built on embracing deep-seated feelings, modeling a "safe place," understanding denial as a natural process manifest within all persons, re-framing accountability as a positive gift to self and others, providing structure and tools toward an offender's journey of self-awareness, and learning to "trust the process." Specific exercises, inventories and other "preparation work" will be provided to participants.

Trainer: David Doerfler, State Coordinator, Victim Offender Mediation/Dialogue, Texas Department of Criminal Justice, Victim Services Division, Austin, TX.

Training L Victim Empathy Training with Offenders (1/2 day afternoon -Advanced)

This training will provide an overview of a 4 day Victim Empathy Training curriculum being used in prisons and community corrections settings (based in part on the 60 hour model developed by MADD & the California Youth Authority). Issues relating to working with those who offend on recognizing harm, developing empathy, forgiveness, and the use of victim panels as part of this training will be discussed. This will be an interactive training, with the focus on over viewing techniques and strategies with limited skills based training. Trainer: Bruce A. Kittle, J.D., MDiv., is an ordained pastor with the United Church of Christ and is the director of Project Hope.

Being aware of our own cultural biases and values is an important step in our journey toward working competently with diverse populations. This interactive training will encourage participants to explore their own values and cultural identity, while gaining a better understanding of how these issues affect our work.

Trainer: Sheri Gatts, Coordinator, VOC Program, Community Adolescent Programs, Madison, WI.

Victim Sensitivity Training ($\frac{1}{2}$ day afternoon -Basic) Training N

This training will focus on the trauma of victimization, including crimes of severe violence. Participants will increase their understanding of the victim's experience and their ability to work sensitively with crimes victims, and will address the ways in which victim offender mediation can assist victims.

Trainer: Jane Riese, LSW is the Bullying Prevention Coordinator for Family-Child Resources, Inc., York, PA, as well as director of the local VOM program.

Training O Innovative Practices for developing Victim Offender Programs: Using ALL of your Public Relations Potential ($\frac{1}{2}$ day morning -Advanced)

Effective Publicity is a must for developing a restorative justice/victim offender mediation/conferencing program. This workshop will help you identify public relations opportunities that are often overlooked and will consider some practical tools for maximizing public relations effectiveness by seizing every public relations opportunity.

Trainer: Rick Rodrick teaches courses in Public Relations and Organizational Communication in the Communication Studies Department at the University of Wisconsin - LaCrosse where he is an Assistant Professor.

Training P Grant Writing 101 (1/2 day afternoon -Basic)

This four-hour training is designed for those individuals who have never written a grant or are interested in pursuing grant funding. The training will provide participants with a general overview of philanthropy and how grant writing fits into the overall development plan. Each participant will be able to conduct prospect research, identify the basic components of a grant, a letter proposal, documentation techniques, and the nuances of grantsmanship. Each participant will work in a group to research a foundation prospect and draft a letter proposal.

Workshop 20 - Truancy Mediation: A Collaborative Approach to Truancy Intervention. The lessons learned from a collaborative pilot program between Jordan School District and the Administrative Office of the Court in Utah will be shared in this workshop (mediation for families as an alternative to juvenile court). The process brought school personnel and the family together to find a solution to the truancy problem. Presenters: Kathy Elton is the Acting Director of Alternative Dispute Resolution Programs for the Administrative Office of the Courts in Utah. She is a co-chair of the VOMA Board of Directors; Kerrie Naylor is currently the principal at West Hills Middle School in West Jordan, Utah and received her Ph.D. in educational administration and leadership from the University of Utah.

Workshop 21 - Grant Writing - The Real Basics

The presentation will provide participants with a basic overview of philanthropy, prospect research and the components of a grant proposal. Each participant will be placed in a group and asked to conduct prospect research using a Foundation Directory. Workshop 22 - Engaging Faith Communities in Restorative Justice

This workshop will explore methods of mobilizing faith communities for direct involvement in restorative justice programming, including strategies and structures.

Presenter: Jean Greenwood, M. Div. Trainer, researcher, writer, and speaker in the field of victim offender mediation and restorative justice; nine years of experience in VOM as mediator and program director.

Workshop 23 - Infusing Restorative Justice into Undergraduate Education

Exploring the possibilities of teaching Restorative Justice to undergraduate students, this workshop will draw on participant's experiences with teaching undergraduates, discuss one case study of a VOM course taught to criminal justice majors, and present results of an informal survey on efforts to infuse RJ into undergraduate curriculums. Presenter: Jeff Gingerich is Assistant Professor of Sociology at Blufflon College and a doctoral candidate in the Department of Sociology at the University of Pennsylvania.

Workshop 24 - Advancing Social Justice Through Restorative Justice

Through dialog among participants this workshop will explore the potential of restorative processes to advance social justice goals. Discussion will attempt to identify ways to maximize the impact on social justice issues. Presenters: Kay Pranis works for the Minnesota Department of Corrections promoting restorative justice and providing support to grassroots restorative initiatives; Don Johnson, Hennepin County Attorney's Office, Juvenile Division. Don participates in the North Minneapolis Community Justice Circle for juveniles and does speaking and training on restorative justice and circles.

Workshop 25A - Addressing Systemic Issues in Victim Offender Mediation/Conferencing (PART 1)

Models such as VOM/C can provide alternatives to court and the larger legal justice system. Some challenges arising from this process include systemic issues such as poverty, inaccessibility to resources, physical and mental disabilities, beliefs and values held by those within the dominant system, etc. In addition to sharing various approaches and ideas to addressing systemic issues, interactive techniques and exercises will be shared utilizing the skills, experience and knowledge of workshop participants. Presenter: Lorna Monkman is a Metis woman from Winnipeg. She has worked with youth in a variety of settings from youth jails to victim offender mediation/conferencing; Sandra Koop Harder has been involved in VOM since 1996 doing volunteer coordination, casework and trainings for Mediation Services, Winnipeg.

Workshop 26 - Some Things IMPACT a Lifetime: A Victims' Voice Heard

Yes, some things do impact a lifetime and because they do, Mothers Against Drunk Driving and the CA Youth Authority developed an innovative educational strategy for offenders. This national program, Victim Impact Classes/Panels for Offenders, stresses personal responsibility and consequences for criminal behavior while emphasizing the victim perspective. This workshop will introduce participants to this program which provides a forum for both victims and offenders to discuss crime and victimization in a non-

Workshop 17 - Recognizing Our own Cultural Biases

Workshop 1 - Issues in Starting a Victim Offender Program This workshop includes: Types of Programs, Types of Cases, Funding and Development, Training and Community Education, Networking and Expansion. The Stakeholders are the key to succes in the development for mediation program. Presenter: Mary Ellen Bowen is the Executive Director of the recently established program Mid South VORP in Hohenwald, TN; Linda Mix, Mediation Services of Putnam County, TN.

Workshop 2 - Spiritual Language Issues in Victim Offender Communication This workshop calls for understanding of and uniformity in language as it relates to spirituality issues such as the distinction between meeting, mediation, and reconciliation; letting go psychologically and forgiving; God's will and God's providence; healing and closure; denial and hope.

Presenters: Together, Janice Lord and Anne Seymour represent nearly 50 years as crime victim advocates. They have filled leadership positions for national organizations and volunteer on numerous national victim coalitions.

Workshop 3 - Restorative Measures: Evaluation of the In-School Behavior Intervention Grants

The In-School Behavior Intervention Grants were awarded to four school districts by the MN Legislature as prat of the three-year demonstration project on school based restorative measures. The first year evaluation report will be presented in this workshop, including project descriptions and purposes, figures, developments and lessons learned. The challenges of tracking attendance and suspensions in all of their forms will be discussed. Workshop 4 - Issues of Diversity

As practitioners working to carry out principles of restorative justice in the work that we do, it is important to recognize issues of race, gender, ethnicity, geography that impact all that we do. This interactive workshop will focus on those issues and look at ways that we can continue to creatively work at solutions that will enhance the principles that guide us. Presenter: Lorraine Stutzman Amstutz is the Director of the Mennonite Central Committee Office on Crime and Justice, Quakertown, PA; Bobbie Boland lives and works in St. John's, Newfoundland. She is in private practice in clinical social work consulting and training; Bruce Kittle is Director of Project Hope, a non-profit faith based organization working with faith communities and governmental bodies in the application of restorative justice principles; Drew Smith is the New Jersey Statewide Restorative Justice Coordinator and has served in the area of juvenile corrections since 1978 in a variety of positions.

Workshop 5 - Transitional Conferencing for Offenders and Families

Transitional Conferencing is a process for offenders and their families to help with community reintegration. The workshop will discuss this process, its roots in VOM and will describe how we meet with an offender, then with their family, and finally with both, so they can express concerns and issues about the transition back to community. Some persons who have experienced this process will be present at the workshop to share their story.

Workshop 6 - Victim Offender Conferencing; Current Northern Ireland Position

With our regional government in suspension, we await an important Criminal Justice Review Publication. This workshop will provide critical analysis and reflection upon the place Restorative Justice holds in our justice system. In a period of political uncertainty, the debate on Restorative Justice is healthy. The various criminal justice agencies appear intent on claiming ownership of the philosophy - no bad thing really as three years ago few had heard of Restorative Justice.

Presenter: Martin McAnAllen with 25 years experience within a probation setting and currently specializing in Youth Justice and Restorative Justice. Martin coordinated the first Victim Offender Conferences in Ireland.

Workshop 7 - Confidentiality in VOM - A False Promise?

Confidentiality is critical when victims and offenders meet whether it is through victim offender meetings, family group conferences or in circles. This panel will look at statutory protections, the Texas Attorney General Opinion and the Uniform Mediation Act to see what the status of program confidentiality is. Constitutional issues will come into this discussion as well as mandatory reporting provisions. Suggestions will be offered on how to design programs with confidentiality in mind.

Presenter: Kathleen Bird, J.D., is the Directory of the Office of Dispute Resolution Services for the 7th Circuit in Kansas City and administers a variety of court-connected mediation programs for Family and Juvenile court.

Workshop 8 - The Role of Forgiveness in Victim-Offender Mediation

What is forgiveness, how is it viewed by society and what role does forgiveness play in VOM? Is remorse or an apology necessary for forgiveness to happen and does this implicate a party's faith or religious views? What role does the mediator play (or not play) in the forgiveness process? This workshop will explore all of these questions and more in a facilitated discussion format. Join us for a lively dialogue on an important issue.

Presenters: Kathy Elton is the Acting Director of Alternative Dispute Resolution Programs for the Administrative Office of the Courts in Utah. Kathy received her Masters in Public Administration focusing on restorative justice and organizational culture; Jan Bellard is the Restorative Justice Project Director for Mediation Network of North Carolina (MNNC). She provides restorative justice and victim offender training for mediation centers, community groups and the Department of Corrections throughout the state.

Workshop 9 - Board development

This one and a half-hour presentation will focus on how to identify, cultivate, recruit and maintain effective Board members. Emphasis will be placed on making Board members aware of their fiduciary responsibilities, as well as setting agency policy. Role playing will be employed as part of the training process.

Workshop 10 - VOC and Prosecution

As gatekeepers to the criminal justice system, prosecutors have great impact on local legal culture. Some prosecutors are receptive to Restorative Justice principles while others claim not to be. Yet, each prosecutor will have handled a case for which RJ principles make sense. This workshop will allow participants to share ideas and explore options in dealing with local prosecutors and local legal culture. Presenter: David Lerman, J.D., has been with the Milwaukee County District Attorney's Office for 11 years and chairs the Milwaukee County Task Force on Restorative Justice, and oversees Milwaukee's Community Conferencing Program.

Workshop 11A - Encountering the Other: Victim Offender Mediation in Serious Crime (PART 1)

This workshop will present an overview of promising models in restorative justice with a focus on Fraser Region Community Justice Initiatives Association's (FRCJIA) Victim Offender Mediation Program, the first state sanctioned and funded program for use in cases involving serious crime. Through lecture, visual aids, and the words of program participants, information will be provided on VOMP objectives, values, principles and process and on the treatment and trauma recovery implications for victims, offender and communities.

Presenters: David Gustafson (M.A., R.C.C.) is Co-Director of FRCJIA in British Columbia, Canada. Dave is also a trauma recovery clinician and Adjunct Professor of Criminology at Simon Fraser University; Sandi Bergen (B.A.) is Co-Director of FRCJIA. She is a case developer and mediator for FRCJIA's Victim Offender Mediation Program for victims and offenders impacted by serious and violent crime.

Workshop 12 - Peacemaking Circles - A Community Partnership with the Criminal Justice System

This workshop will provide an overview of the Peacemaking Circle process and descriptions of a variety of projects in different communities. Circles are being used for sentencing, for support while in institutions and for reintegration into the community. Presenters: Kay Pranis works for the Minnesota Department of Corrections promoting restorative justice and providing support to grassroots restorative initiatives: Gwen Chandler Rhivers works for the YWCA of St. Paul and participates in the Summit University/ Frogtown Community Circle in St. Paul. She also uses circles in the transitional housing program she directs for the YWCA.

Workshop 13 - "Are Girls as Difficult to Provide Services for as they Say?"

"Yes" is the answer from many juvenile justice service providers. This may help explain why most service delivery systems were designed for males and are fraught with bias - intentional and unintentional. No wonder girls resist our interventions! This workshop will discuss the differences in psycho social development between boys and girls, the societal context in which girls live, and what effective gender responsive services are for girls.

Presenter: Paula Schaefer does program development and provides technical assistance and training for service providers on gender specific services for girls and restorative justice. Paula learns a great deal from girls and is inspired by their indomitable spirits.

Workshop 14 - Maintaining a Healthy Volunteer Program The maintenance and development of a skilled and healthy volunteer VOM/C program is critical in working together with victims and offenders involved in programs. This interactive workshop will explore creative ways to nurture our volunteers in their roles as mediators. This includes providing feedback, mentorship programs, structured preparation and debriefing processes and professional development opportunities specific to VOM/C.

Presenters: Sandra Koop Harder has been involved in victim offender mediation since 1996 doing volunteer coordination, casework and trainings for Mediation Services; Veronica Joseph, Caseworker (former volunteer). Prior to working with Mediation Services, Veronica had been a volunteer mediator for three years. She has worked in both youth and adult mediation programs.

Workshop 15 - Peacemaking and Spirituality

This workshop will examine the role of spirituality for people working in the field of restorative justice and VOM/C with a focus on the harm caused by crime. For this workshop "spirituality" is not synonymous with dogma, creed or other aspects of major religions, although for some people religion may be a pathway to their own spirituality. Participation requires openness and acceptance of diverse religious and spiritual beliefs and practices.

Presenters: Mary Sam is the Director of the Indigenous Justice Project at the Center for Restorative Justice and Peacemaking and the Chemical Health and Multicultural Coordinator of Robbinsdale Armstrong High School; Mark Umbriet is Director of the Center for Restorative Justice and Peacemaking at the University of Minnesota and is known worldwide as a researcher, author, practitioner and trainer.

Workshop 16 - "Bullying" in Schools

Bullying or peer abuse, is a common phenomenon among young people in schools. This workshop will define the problem and explore the use of VOM and restorative responses to address this underserved group of victims and offenders. York, PA is just the 6th site in the US to receive training to implement this research based "Blueprints" Violence Prevention Program, created by Dan Owens of Norway. Presenter: Jane Riese, LSW is the Bullying Prevention Coordinator for Family-Child Resources, Inc., York, PA, as well as director of the local VOM program.
